

Gunspot.com Gun Ammo Giveaway Contest

- DATE OF Sweepstakes

Sweepstakes begins at 12:00:01 Central Time ("CT") on Friday, March 5th, 2021 and ends at 11:59:59 CT on April 14th, 2021 (The "Sweepstakes' Period") **The sweepstakes comprizes of 3 seperate drawings and prized as outlined below.**

- ELIGIBILITY

Sweepstakes is open only to legal residents of the fifty (50) United States, the District of Columbia, excluding Puerto Rico, who are Twenty One (21) years of age or older as of the date of entry (the "Entrant"). Void outside of the fifty (50) United States and Puerto Rico, excluding the District of Columbia, and where prohibited, taxed or restricted by law. Officers, directors, managers, and employees of Gunspot.com or Machineguncentral.com (the "Sponsor"), and each of its respective parents, subsidiaries, affiliates and related companies and their respective advertising and promotion agencies, consultants and agents, as well as immediate family members and/or those living in the same household of each such person, and any others engaged in the development, production, execution or distribution of this sweepstakes are not eligible to participate. "Immediate family member" shall be deemed to mean husband, wife, children, mother, father, sister, sister in law, brother, brother in law. Sweepstakes may only be entered in or from the fifty (50) United States and the District of Columbia, excluding Puerto Rico and any State or other jurisdiction that are not eligible for entry. - HOW TO ENTER...

Entrants creating a free account on Gunspot.com will receive 1 entry. ALL previous Gunspot Accounts that have been created will automatically receive 1 entry.

ONE 9mm Bullet will be added to the total giveaway FOR EVERY NEW ACCOUNT created during the sweepstakes time period. So, if 1,000 new accounts are created during the sweepstakes contest period, then 1,000 bullets will be given away.

Three (3) Total winners will be drawn, and will split the ammo total in 1/3rds.

Neither Sponsor nor any Sweepstakes Entity is responsible for any entry that is lost, late, ineligible, incomplete, invalid, or unintelligible, whether due to system errors, omissions, interruption, deletions, defects, delay in operations or transmissions, or destruction or failures, faulty transmissions or other telecommunications malfunctions, human errors, entries not received resulting from any Hardware or Software Failures of any kind, lost or unavailable network connections, failed, incomplete, or garbled computer or phone transmissions, typographical or system errors and failures, faulty transmissions, technical malfunctions, or otherwise. - DRAWING/ODDS

On or about April 15th, 2021, potential prize winners will be selected in a random drawing from all eligible entries received. Odds of winning depend on the number of eligible entries received for the

Sweepstakes. By entering the Sweepstakes, Entrants fully and unconditionally agree to be bound by these Official Rules and the decisions of the Sponsor and Sweepstakes Entities, which will be final and binding in all matters relating to the Sweepstakes.

IMI 9MM 115gr. Ammunition

- PRIZE RESTRICTIONS

Prize is non-transferable or assigned and no substitutions or cash redemptions; except at Sponsor's sole discretion or as otherwise provided herein. Sponsor will not replace any lost or stolen prize. Prize winner is solely responsible for all applicable Federal, State, and local taxes, including taxes imposed on his/her income. No more than the stated number of prizes (1) set forth in these Official Rules will be awarded. Sponsor will transfer the Prize to the selected FFL according to ATF and State Laws, Rules, and Regulations. It is the prize winner's responsibility to pay all applicable taxes, transfer fees, and do all applicable paperwork with selected FFL to get Prize transferred into their possession.

- NOTIFICATIONS/CLAIMS

Monthly PRIZE: Potential Monthly Prize winners will be notified by email (if registered on Gunspot) OR via Facebook Messenger on or about the 1st day of the Month FOLLOWING the designated contest period (the "Notification"). Prize winners will be required to sign and return (except where prohibited) a notarized Affidavit of Eligibility and Liability/Publicity Release and a W-9 Tax Form (the "Paperwork") within fourteen (14) days of the Notification. If any Prize winner is found to be a minor in his/her jurisdiction of residence (but must be over the age of 21), the prize will be re-drawn and a new winner

awarded or until one is of legal firearm age (21 Years or older). After verification of the Affidavit, Prize will be shipped using Federal Express courier service. Potential Prize winner must return the Paperwork within the date and time indicated in the Notification. If the potential Prize winner fails to return the Paperwork within the date and time indicated in the Notification, or is found to be ineligible, or if he/she does not comply with the Official Rules, such potential Prize winner and his/her entry will be disqualified and another potential Grand Prize winner will be selected from the remaining eligible entries received. If the Notification is returned as undeliverable, this will result in a potential disqualification and an alternate Prize winner will be selected from all remaining eligible entries.
